

Catch the Bugler 4.0-Mile Run, 6:30 p.m., July 8, 2016 Centre Square, Easton, Pa

Run and support Easton Area Heritage Day, the event that is put on each year by a group of dedicated volunteers in historic downtown Easton to commemorate the reading of the Declaration of Independence. Easton Area Heritage Day is a 501c(3) non-profit group.

On July 8, the Bugler will “come down” from a top of the Sailor and Soldiers Monument and runners will try to catch him over 4 miles. The race will be professionally timed by Pretzel City Sports and results will be posted on www.pretzelcitysports.com the first business day after the event.

The race will begin at in front of 18 Centre Square at 6:30 p.m., wind through downtown Easton and head onto the D&L Trail before a turn around point on the trail and then head back to Scott Park, for a party. A water stop will be at the 2-mile mark, but personal water is suggested as it is very warm in July.

At the finish line party in Scott Park, music will be provided by DJ Brad F. Scott, food trucks available, awards and beer (if you’re 21+). Awards will be given to the first three finishers, as well as the top male and female in the following age groups: 18 and under, 19-29, 30-39, 40-49, 50-59 and 60+.

A \$20 registration fee gets you into the race and a commemorative mug, if you sign up before June 24. Sign up price starting June 25 is \$25 and mugs until they last. All registrations also gets you a free beer at the finish line, if you’re 21+. Please have ID with you day of the race.

Day-of packet pick-ups and sign-ups start at 5 p.m. near the start of the race. Mail-in registration is also accepted and can done using the form below. A date will be set for packet-pick up a day or so before the race.
