# Falling Leaves 5k Run

& 1 Mile Fun Run/Walk

**LOCATION:** The Bucks County Horse Park, 8934 Easton Road (Route 611), Revere, PA. Registration and number pickup opens at 7:30 a.m in the Pavilion. 5k starts at 9:00 am, Fun Run/Walk at 10:00 am. T-shirt to all pre-entries & race-day entries while supplies last. Clock at finish, refreshments, equestrian demonstrations. Rain or shine. No refunds or mailed awards. Stay for the Nockamixon Community Day festivities!

**COURSE:** Cross Country 5k race with hills, optional jumps, and water crossings. GPS measured course through the bucolic Bucks County Horse Park. A unique opportunity to enjoy this member only facility!

**AWARDS:**

**5K:** Separate awards for the male and female winners plus: 1<sup>st</sup> through 6<sup>th</sup> place ribbons for male and female in the following: 18 & under, 19-29, 30-39, 40-49, 50-59, 60 and above.

All Fun Run/Walk finishers will receive a small prize.

**ENTRY:** \$25 - ONLINE ENTRY PREFERRED [www.buckscountyhorsepark.org](http://www.buckscountyhorsepark.org). Online entries will close September 10<sup>th</sup>. Mailed entries - \$25 if postmarked by Saturday, September 3<sup>rd</sup>. Late and post (day of race) entries, \$30.

**DIRECTIONS:** The park is located on Route 611 between Revere and Ferndale, PA., approximately 15 miles north of Doylestown and 18 miles south of Easton. From the south, it is on the left 1/2 mile north of Revere. From the north, it is on the right just less than a mile south of Ferndale.
