10K Run & 5K Walk

Saturday February 8, 2025 @ 9:30am

Location/Registration: Race starts and finishes at 180 Forest Rd. Denver, PA 17517. Parking is in stone or grass areas. Registration/Bib pickup opens at 8:00am with the race beginning promptly at 9:30am. Kids fun run registration is available up until 11am start. Cash or Check only for all race day registrations.

Race will take place rain, shine, or snow - as long as roads are driveable.

Course: GPS measured 5K loop will take you through well groomed grass dog training trails as well as up long climbs with some fast decents to follow. The 10K timed race will run the loop two times. The untimed, non-competitive, 5K will complete the loop once.

Amenities: One water stations on course that you can utilize multiple times, bathroom facilities, wash hose, free post race raffles & unisex long sleeve race shirt for pre-registered participants.

10K Awards: Cash and awards will be given to the top M/F overall. Age group medals will go three deep M/F as follows: 19&Under, 20-29, 30-39, 40-49, 50-59, 60-69, 70+

10K Run Entry: 40\$ w/ shirt if postmarked by Jan. 15st. 30\$ after that date, up to and including race day; no shirt.

5K Walk Entry: 25\$ w/ shirt if postmarked by Jan. 15st. 15\$ after that date up to and including race day; no shirt.

Kids Fun Run: Post race ½ mile kids fun run for ages 12 & under. 5\$ up until and including race day, shirts not included. Finisher medals & goodie bags (while supplies last) to all fun run finishers. (Race Start approx. 11am)
